Just over 30 years ago, the Sussex Neighbourhood House (SNH) was officially opened in 1991 by the then Premier of Victoria, Joan Kirner, and Hazel Hawke (wife of the local federal member and Prime Minister, Bob Hawke) at 235 Sussex Street, Pascoe Vale.

Twenty-six years later, in January 2018, we moved into the new Moreland City Council purpose built facility at 7 Prospect Street, Pascoe Vale. Through the services that SNH provides, we strive to make a positive difference in people's lives. We are an incorporated association, with membership from the local community.

The activities and programs we provide are developed in response to the needs of the community. Our brand is built not from our communication materials or our mission statement, but rather by the day to day interactions we have with community.

We are a not-for-profit organisation where funds are combined with a strong staff and volunteer input to ensure maximum benefit to our diverse community.

Our funding support comes from a range of funding agencies, including Dept. of Health and Human Services, Dept. of Education & Training, and Merri-bek City Council. We operate to our <u>Constitution</u>, a three year <u>Strategic Plan</u>, and the Neighbourhood House's Good Practice Standards.

CHAIRPERSON'S REPORT

I'd like to share a few of my thoughts on having the privilege of being Sussex Neighbourhood House (SNH) chairperson since the beginning of the year. This has been an incredibly rewarding position and one that I have appreciated even more so now having been in the role. Although I've been with the house for over two years now, I feel that the role as a chair has enabled me to really understand the depth of the work required to ensure our neighbourhood house provides stability, clarity of role and a culture of inclusiveness and innovation. This confirms our Mission to "Provide a hub that connects, creates, and supports our community through lifelong learning, social activities and by responding to community needs".

There have been many activities which have occurred at SNH over the past 12 months which I've been proud to support as a part of Governance team. The Committee of Governance (CoG) continues to evolve, and we anticipate increasing numbers, which will ensure a level of specialist expertise, which is very exciting.

As part of the Manager's role, Joe Cassar, has been providing the CoG a monthly report which is extensive and provides an in-depth analysis to all the activity such as staffing arrangements, budgetary applications, OHS, building works and much more.

As part of the SNH 2022-2025 Strategic Plan priorities, we have been focusing on Youth, Young Families and Children, and Disability. SNH has had numerous key achievements over the past 12 months regarding these priorities and a few highlights include:

- Expanding our youth program offerings
 for example, Youth Artspace and the Home Educators Social Group.
- 2. Additional Scallywags playgroups and partnership with Merri Health School Ties program to increase offerings for young primary school aged children.
- Partnership with Glenroy Specialist School and the delivery of the Creative Movement and Dance program to senior students at the school.

Reflecting on SNH strategic planning and goals, I have re-read previous Annual reports and one struck me by former Chairperson, Claire Martin in 2017-2018: "It is our intention to grow into this new facility by expanding our activities and programme so that we are catering to social need, lifelong learning, cultural diversity and supporting and empowering everyone who engage with us". Despite many adversities, particularly Covid, I am confident we have been achieving these intentions set out by previous committees and hope we continue to do so in the year ahead. I encourage everyone to have a look at SNH: Statement of Aims and if you'd like to be directly involved in helping us, I hope you'll consider becoming a committee member.

Welcome to all new members and for all returning members, we are humbled and thrilled that you've chosen to be a part of this community hub. We look forward to serving you in the coming year and hope you'll share with us any commendations on how our House is working, as well as any suggestions on continued improvement.

GENERAL MANAGERS REPORT

Over the last 12 months, it has felt like we are beginning to experience a 'new normal' post the Covid lockdown years! The local community has enthusiastically returned to the House, programs are running smoothly, and participation rates are high. The House is full of life – often from morning through to the evening.

In 2023, SNH welcomed the opportunity to work in partnership with the Merri-bek City Council in making changes to the leasing and operations of the Pascoe Vale Community Centre. The civic area now operates much more as an integrated hub. The community architecturally designed Children's Centre is now being used fulltime as much-needed а kindergarten and joins Maternal Child Health on the first floor of the building. We are now seeing families and children routinely using both services as well as accessing other programs offered at SNH. Additionally, SNH now operates the Pool Hall, which is located adjacent to the Pascoe Vale Swimming Pool. This change has resulted in an increase in the utilisation of the Pool Hall and improved integration with programs at SNH. For example, some members of the seniors' group, the Association, and the Pascoe Vale Spinners and Weavers are now regular attendees at SNH programs and events. New users to the Pool Hall, such as the SNH Skylarks Choir, numerous Yoga and Tai Chi classes, a weekly faith group and children's party hire are all now thoroughly enjoying the space. Going forward we hope to further develop program connections with the Pascoe Vale Swimming Pool.

As part of our efforts at increasing SNH room hire utilisation, a focus this year has been on increasing access to aligned social purpose organisations. For example, we

have welcomed Dare Drama, Women's Health in the North, and Edmund Rice Community Services to SNH. All have helped to reflect the rich diversity of the local community and have added energy and vibrancy to the House.

The past year has seen SNH strengthen existing sustainability programs as well as trying out new initiatives. Some examples include:

- The Pascoe Vale Food Collective, an auspice of SNH, is now in its third year and is building year on year in providing monthly distribution days of wholesome, sustainable food without packaging to the local community as well as facilitating an annual Makers Market Day.
- The monthly Pascoe Vale Repair Café is now in its second year and is continuing to grow with a band of regular volunteer repairers and locals who are seeking to reduce landfill and learn how to get things fixed. SNH was successful in securing a small community grant from Essendon Fields to assist in coordinating and facilitating Repair Café events and to fund volunteer training and purchase required tools and materials.
- Our annual SNH Earth Day and Winter Solstice events have now been held for the past two years. Both events celebrate the Earth and encourage care of our environment. Supported by Merri Health School Ties funding we have had more success in engaging children with a 'Sustainability - focusing on the next generation' approach.
- We have trialled a Sustainability Champions workshop for primary school children in our school holiday school program and introduced an edible garden for our preschool playgroups to water and feed our collected food waste to the worms.

- We have added Project Pair Up (to match missing plastic lids and containers) and the collection of used aluminium coffee pods to our existing collection of plastic tags and bottle tops.
- Our Sewing, Craft Circle and Makers, Menders & Basketry groups continue to meet weekly. As well as providing social opportunities, importantly they support and role model skill development in repair, reuse, and up cycling.

Improving on our disability programs has continued to be a key operational focus this year. To revitalise our 25-year Inclusive Arts programs, classes were shifted from early evening to day timeslots. This resulted in additional staff and volunteers being on hand to support participants of program. Following extensive communications with Merri-bek Council disability networks and other local services, like Yooralla, the program is now thriving. With the support of a VicHealth Jumpstart grant SNH partnered this year with the Glenroy Specialist School with the aim of building relationships and pathways for students leaving school to attend local mainstream creative arts programs. Finally, whilst all programs at SNH are inclusive, an emphasis has been placed on supporting existing programs and developing new programs that are accessible and inclusive. such as our Art Space program and new programs, such as the Home Educators Social Group and Chatty Café.

All the achievements of the past year would not have been possible without the teamwork, commitment, and hard work of so many. The work of the office staff, SNH Committee of Governance, reception and

program volunteers, and sessional program staff and contractors, has again been enormous.

TREASURER'S REPORT

I am truly honoured to present both this year's Treasurer's Report for Sussex Neighbourhood House as well as the audited financial reports for the year ending June 30, 2023. The past year has been nothing short of exceptional, with SNH operating at full capacity and highlighting the profound positive impact it has had on our community.

The performance of SNH over the past year has been truly remarkable. With our operations running at full throttle, we have witnessed a near doubling of revenue from program fees and room hire charges compared to the previous year. This not only reflects the community's enthusiastic embrace of our programs but also their keen interest in utilising our facilities.

I would like to extend my heartfelt appreciation to Joe and the entire team for their unwavering dedication to ensuring the seamless operation of our House. They have also worked tirelessly to secure additional grants, enabling us to offer an even wider range of programs to our community. I am thrilled to announce that the team has successfully secured a total of \$435,250 in grants, marking a significant increase of \$77,062 from the previous year. This speaks volumes about the value that our House brings, not only to our local community but also to the government organisations that assess and allocate these grants.

As we resumed our full program offerings and community services, it was only natural that our costs would rise. Materials and sub-contractor fees saw substantial increases, signifying a positive trend as more people returned to our House to use our services. Our expenditures on employees and program fees also increased this year, rising from \$492,579 to \$562,990.

Considering that we received the last of the COVID-19 grants in 2022, the fact that we were able to generate a commendable profit of \$34,617 is a testament to Joe and the team's exemplary expense management, particularly in the face of rising costs that all organizations are currently grappling with.

Our Balance Sheet stands on a solid foundation, with total assets amounting to \$424,319, of which \$407,472 is in cash and cash equivalents. Total liabilities stand at \$140,647, which includes provisions for annual leave and long service leave amounting to \$18,629, as well as \$69,389 in income & grants in advance.

I want to extend my heartfelt congratulations to the entire team for their outstanding efforts and achievements.

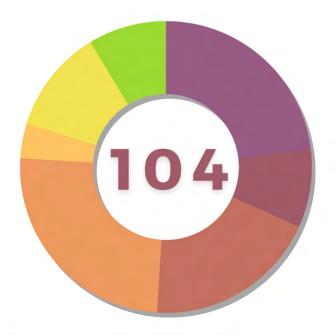

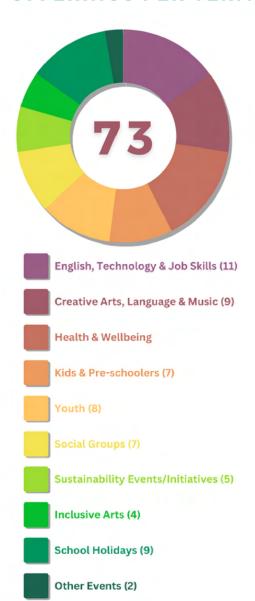

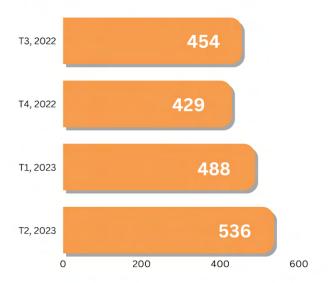

ENGLISH, TECHNOLOGY & JOB SKILLS

Adult Community Further Education programs, otherwise known as Learn Local, offer valuable community based pre accredited training programs that can be flexibly delivered, are relaxed in nature and importantly offer an accessible entry point for adult learning.

English Programs

English as an Additional Language (EAL) classes continue to be well-attended and staple of SNHs Learn Local program offerings.

We have continued to successfully provide EAL at three local primary schools - St Dominic's Primary, Glenroy West Primary School and Belle Vue Park Primary School. At all three schools, parents comment on how convenient it is being able to drop their children at school and then head straight to the school community hub for EAL classes with other parents at the school.

Our English language classes, including our class for people over 60, have also continued to be popular and well attended. Students report an increase in confidence in participating in everyday life and most importantly in seeking further education, training and employment opportunities.

Many of the students attending EAL classes have done so for more than a single term and tell us that taking the time required to consolidate their English language skills is important to them. Students all tell us that EAL classes provide a much-needed opportunity to socially connect which is equally as important as the learning itself.

Computers & Technology

The existence of a growing digital divide in Australian society is becoming more understood. As we all know, it has become increasingly difficult to do many things in everyday life - without a digital device or a smart phone. The role SNH plays in supporting people to become more digitally skilled and comfortable with digital devices is more important now than ever.

SNH offered a suite of computer/digital literacy classes in 2023. During the course of this year, we worked towards building the confidence in using smart devices making life easier and enjoyable. All were well attended, and all received positive feedback on just how helpful they are.

The classes offered over the last year include.

- Smartphones, Tablets and Computers for Beginners
- Digital Skills for everyday life
- Digital literacy for job seekers
- Computers for Absolute Beginners
- Smartphones for Absolute Beginners

Our Computer and Technology skill classes are complemented by digital mentoring offered to individuals aged over 50 and funded though the Be Connected program. To date, 25 learners have engaged in this program.

DIGITAL MENTORING

From February 2023, thanks to the federal-government-funded Good Things Foundation "Be Connected" program, SNH has provided one-on-one digital support for community members aged over 50.

As a place-based community organisation, we see and hear first-hand how people struggle accessing and navigating technology, and the resulting isolation and lack of confidence this can cause. To date, we have provided mentoring assistance to 25 people and received positive feedback from all involved.

Establishing a one-on-one digital mentoring program has been beyond rewarding. I've not only been able to assist learners with navigating their devices to accomplish daily tasks, but also show them a world of possibilities they can delve into.

Job Skills & Development

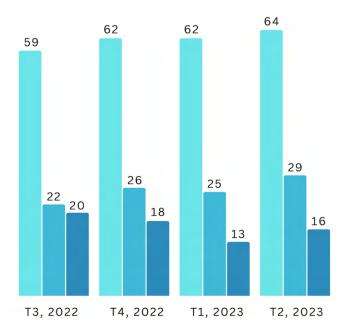
In 2023, SNH has continued to offer Introduction to Youth & Community Services, and Let's Shoot: Introduction to Screen and Media. These classes engage younger learners, a difficult cohort to reach.

Due to increased community interest in sustainability and the importance of reusing and recycling we added Introduction to Sewing as a course offering.

From introducing a younger student cohort to community work, learning sewing skills and filmmaking, our Job Skills Development program continues to equip learners of all ages with new skills for work, life and further study.

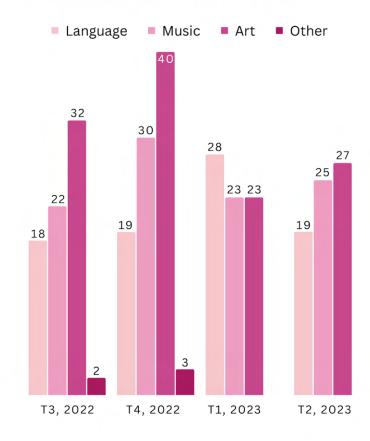
CREATIVE ARTS. LANGUAGE & MUSIC

HEALTH & WELLBEING

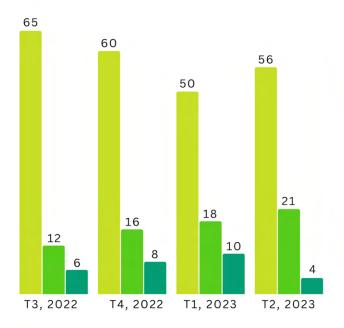

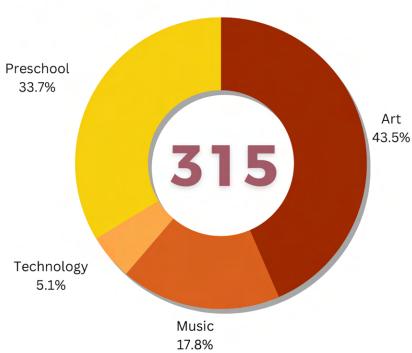

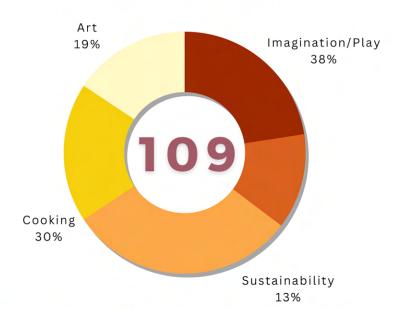
SCHOOL HOLIDAY PROGRAMS

YOUTH PROGRAMS REPORT

2023 has seen SNH continue its work to expand and strengthen offerings aimed at young people. We successfully delivered on a 12-month Vic Health Jumpstart Grant to support children, youth and young adults with a disability (aged 5 - 25) and we are now in the second year of a three-year youth engagement project supported by funding from the state government's 'Engage!' program for young people aged 12 - 25. Many of our programs have been initiated by local community groups and reflect the interests of young people we have consulted. Some examples include, creative arts, chess, video games, coding, screen and media.

Over 2023, we have recorded in excess of 250 engagements with local young people, with our activities supported by 17 individual youth volunteers and placement students across our programs.

In particular, we note the diversity of young people attending our programs, with attendees from across the gender identity spectrum and a variety of linguistic backgrounds. Of the engagements we recorded, 46% were female, 42% male, and 12% unspecified or non-binary. 37% of engagements came from young people from multicultural backgrounds, and 27% came from young people with a disability.

We are proud to note a high level of participation from neurodivergent young people in our programs, which reflects our commitment to creating an inviting and inclusive space for social interaction. While the majority of participation comes from younger teens aged 12 – 15, we have also seen an older age range of 18 – 25-yearolds attend our 'Let's Shoot' media training program, as well as 'The Pop-Up Painting Society', a workshop focusing on paper construction and watercolour.

Designed to build trusting relationships and future access pathways to SNH programs, we delivered a creative music and dance program at the Glenroy Specialist School. This involved offering 6 sessions to 10 senior school students who will be transitioning from school to community activities after they graduate in 2023. The program concluded with the whole senior school (approximately 40 students, many supported by staff or family member) coming together in a shared creative movement session in the school's assembly area. The program was extremely well received by students and school staff.

Youth programs at SNH continue to be supported by valuable partnerships with RMIT University, who have supported our media training program with excursions to their media precinct in the city, as well as the Australian Catholic University, whose volunteer partnership scheme enables us to continue to offer free one-on-one high school tutoring in our online homework club. We are also grateful to Youth Projects, the Inner North Local Learning and Employment Network, the Centre for Multicultural Youth, and Merri-bek Youth Services for their ongoing work networking, promoting and collaboration with SNH to support the growth of our youth programs.

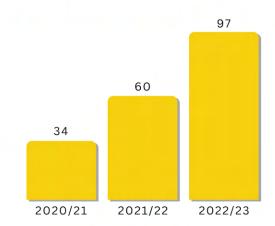

SOCIAL GROUPS

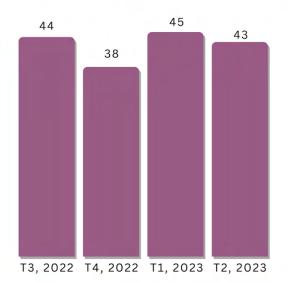

AUSPICEE REPORT

Pascoe Vale Food Collective (PVFC) is now in its third year. We are fully volunteermanaged and continue to supply wholesome, sustainable food without packaging to the local community during Distribution days, once per month, at the Pascoe Vale Senior Citizens Centre.

We source as local, and as ethically as possible, non-perishable food and cleaning products, and provide these package free to our members and the community at low prices. As much as possible we try to minimize excessive food miles and excessive packaging, whilst ensuring that growers are reasonably paid for their work. We offer a welcoming space for the whole community.

The PVFC stocks 70 basic pantry & washing/cleaning products. Members and casual visitors can bring their own containers to be filled with as much or as little as they need. Packaging is minimized and the Collective ensures responsible reuse or recycling of the packaging we receive.

We held our third Makers Market in March to celebrate another year enabling us to support some local small home-based businesses. It was a successful day with over 100 people attending.

Our sales and attendances each month remained steady throughout the year. This financial year we sold \$9,888.00 worth of products and collected \$969.20 in membership fees. For the same period, we outlaid \$7,831.62 to purchase products. Our bank balance on 30 June was \$5,798.79. Our membership base for the period was 37.

At the end of June, we had 6 committee members. We have not applied for any grants this year.

It has continued to be another exciting year, and we look forward to the continuing success of the Collective and hope to continue to grow our presence and member base.

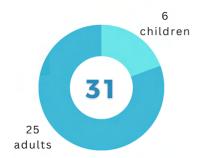

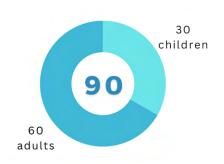

Note 1. Statement of Significant Accounting Policies

This financial report includes the financial statements and notes of Sussex Neighbourhood House Inc, an incorporated association, which is incorporated in Victoria under the Associations Incorporation Reform Act 2012.

Basis of preparation

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the *Australian Charities* and *Not for Profits Commission Act* 2012 and the *Associations Incorporation Reform Act* 2012. The committee has determined that the association is not a reporting entity and also a not-for-profit association.

The financial report has been prepared on an accruals basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

The following is a summary of the material accounting policies adopted by the company in the preparation of the general purpose financial report. The accounting policies have been consistently applied, unless otherwise stated.

Accounting Policies

a. Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Plant and Equipment

Plant and equipment are measured on the cost basis less depreciation and impairment losses.

The carrying amount of plant and equipment is reviewed annually by directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets' employment and subsequent disposal. The expected net cash flows have been discounted to their present values in determining recoverable amounts.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the company and the cost of the item can be measured reliably. All other repairs and maintenance are charged to the income statement during the financial period in which they are incurred.

Depreciation

The depreciable amount of all fixed assets are depreciated over the useful lives of the assets to the Committee commencing from the time the asset is held ready for use.

The asset's residual values and useful lives are reviewed and adjusted, if appropriate, at each balance date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the income statement.

b. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities on the balance sheet.

Note 1. Statement of Significant Accounting Policies (continued)

c. Revenue

Grants are recognised at fair value where there is reasonable assurance that the grant will be received and all grant conditions will be met. Grants relating to expense items are recognised as income over the periods necessary to match the grant to the costs they are compensating.

Grants received for specific programs are recognised as income only to the extent of work completed on those projects when the terms of the grants stipulate that any unexpended funds are to be returned to the sponsor if the program is not completed. In those circumstances the funds attributable to work still to be completed are carried forward as grants income deferred.

Revenue is measured at the fair value of the consideration received or receivable.

Revenue from the sale of goods is recognised at the point of delivery as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement in those goods.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

Revenue from the rendering of a service is recognised upon the delivery of the service to the customers.

All revenue is stated net of the amount of goods and services tax (GST).

d. Income Tax

By virtue of its aims as set out in the constitution, the Association qualifies as an organisation specifically exempt from income tax under Section 50-45 of the *Income Tax Assessment Act* 1997.

e. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense. Receivables and payables in the Balance Sheet are shown inclusive of GST.

f. Employment Entitlements

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits that are expected to be settled within one year have been measured at the amount expected to be paid when the liability is settled. Contributions are made by the association to employee superannuation fund and are charged as expenses when incurred.

g. Provisions

Provisions are recognised when the Association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

h. Related Party Transactions

The Committee Members act in an honorary capacity and are not paid for their services as Committee Members.

There were no transactions with related parties during the 2023 year.
