2024-2025 LEADERSHIP & FINANCE REPORT

As Chairperson of Sussex Neighbourhood House, I am proud to present this year's Annual Report in collaboration with our General Manager, Joe Cassar.

Guided by the theme "Building on our Past, Shaping our Tomorrow," this summary reflects a year of steady governance and dynamic community engagement.

Our Committee of Governance has grown stronger through strategic recruitment and succession planning, ensuring continuity and resilience. A key focus this year has been the development of our 2026-2029 Strategic Plan, shaped through meaningful consultation with our community and designed to guide our future direction.

We honour the contributions of both past and present committee members whose dedication has laid the foundation for our current success and future direction.

Operationally, SNH delivered an incredible suite of inclusive programs and our finances are in good shape.

We have maintained a balanced budget for the fourth consecutive year and additionally have invested \$20,000 in the INCF SNH MyFund to support community giving - demonstrating sound financial stewardship and a commitment to longterm sustainability.

A summary of our financial position:

- cash balance at July 1, 2024 of \$384,974
- income received \$720,408
- expenses paid \$721,141
- cash balance at 30 June 2025 \$385,090

Finally, the committee and I would like to acknowledge the outstanding efforts of our operational staff, whose creativity, care, and professionalism have driven program excellence, strengthened community connections, and ensured the smooth running of the House.

Together, we look forward to shaping a vibrant future for our community.







RANGE OF PROGRAM OFFERINGS



















LANGUAGE & COMMUNICATION

This year saw a 50% increase in participation across our English classes. Thanks to the Family Learning Partnership, we expanded our programs to support an additional 30 young parents and grandparents learning English. We now offer five classes in Hume, alongside our six well-established classes in Merri-bek. We have also welcomed a volunteer led conversation group.

Social work students Grace and Eden spent time listening to our English learners and produced a detailed report highlighting the key factors that support students to access and benefit from these programs.


Our language learning community also broadened beyond English, with Carolina continuing to teach Spanish while sharing food, stories, and culture, helping participants embrace language through connection and diversity.





PASCOE VALE FOOD COLLECTIVE

AUSPICEE REPORT



Pascoe Vale Food Collective (PVFC) is in its fifth year. We are proudly volunteer-run and continue to supply wholesome, sustainable food without packaging to the local community during Distribution days, once per month, at the Pascoe Vale Senior Citizens Centre.

We source as local, and as ethically as possible, non-perishable food and cleaning products, and provide these package-free to our members and the community at low prices. As much as possible we try to minimize excessive food miles and excessive packaging, whilst ensuring that growers are reasonably paid for their work.

We offer a welcoming space for the whole community. We also provide tea and coffee and delicious snacks for everyone to enjoy while they wait to be served.

Achievements

We held Members Celebration in March for our 4th birthday, to thank our wonderful members and celebrate our achievements. Members each took home a sustainable party bag containing packaging-free goodies that were bought wholesale and assembled by our committee.

We also donated \$200 to Hope Cafe, a wonderful local organisation who provides a weekly three-course meal to people in Fawkner who would like to join in. Thank you to our members for making this possible. As a thank you to our volunteer members, we now offer a 10% discount on their shopping on the days that they volunteer.





Since joining this wonderful collective nearly 5 years ago I've been a regular monthly shopper and twice-yearly volunteer. I now think more carefully about how much I need to buy. I re-use the same containers for dozens of dry and household goods. And I enjoy a cuppa with neighbourhood folks and their families as we learn a slower, more mindful way of shopping. The collective has also developed links with other like-minded folks like local honey producers and community gardens, whose wares are available to buy and swap. It's completely transformed what was the stressful weekly chore of shopping into something more like an enjoyable social gathering. Prices are cheaper, products are good quality and I love knowing that I'm making sustainable choices in my daily life. Feel blessed to be part of this lovely local community.

PASCOE VALE REPAIR CAFÉ

In 2025, the Pascoe Vale Repair Café thrive as hub of continued to а sustainability, skill-sharing, and community connection. Across the year, 665 repair requests were brought through our doors, with an impressive 558 items restored to use - an 84% success rate. On average, 10 dedicated volunteer repairers joined each month, offering their time and expertise to help neighbours extend the life of their belongings. We were delighted to welcome seven new volunteers over the year, further strengthening the pool of skills available at each session.

Our enthusiastic rotation of ladies from the Pascoe Vale Hand Spinners & Weavers continue to share their textile expertise, patching holes in woollens and bringing beloved toys back to Alongside them, members of the Merri Community Shed regularly offer their abundance of knowledge in woodwork, mechanical, and electrical repairs, relishing the challenge of tinkering with various items. Sessions also featured practical tapfixing demonstrations, helping locals pick up new skills for maintaining their homes. The Repair Café continues to embody the values of sharing, sustainability, resilience, reinforcing the message that repair is always better than waste.

Companionship, community, and laughter all contribute to the welcoming atmosphere at the Repair Cafe. It's lovely to see the delight on people's faces when something is fixed and to share in that feeling of



Sustainability remains a cornerstone of our work. This year, our community remarkable volunteers have made contributions to reducing waste encouraging greener practices.

The magnitute of lids and tags sorted was only possible thanks to the dedicated commitment of our volunteer Vicki Petropoulos. Many of the lids were shared with Northcote High School who have the Precious Plastics machinery to repurpose the lids for their Product Design & Technology classes, turning waste into hands-on learning opportunities.

In addition to recycling and reuse efforts, we partnered with Merri-bek City Council in April 2024 to expand access to sustainable transport. The Merri-bek E-Bike initiative was launched, offering residents a no-cost two-week trial of an e-bike. Since inception, the program has supported 40 local residents to experience the benefits of cycling, encouraging healthier lifestyles, and reduced reliance on cars.

These initiatives highlight the strength of community-driven sustainability: actions coming together to create lasting environmental impact.





Note 1. Statement of Significant Accounting Policies

This financial report includes the financial statements and notes of Sussex Neighbourhood House Inc, an incorporated association, which is incorporated in Victoria under the Associations Incorporation Reform Act 2012.

Basis of preparation

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Australian Charities and Not for Profits Commission Act 2012 and the Associations Incorporation Reform Act 2012. The committee has determined that the association is not a reporting entity and also a not-for-profit association

The financial report has been prepared on an accruals basis and is based on historical costs, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities.

The following is a summary of the material accounting policies adopted by the company in the preparation of the general purpose financial report. The accounting policies have been consistently applied, unless otherwise stated.

Accounting Policies

a. Property, Plant and Equipment

Each class of property, plant and equipment is carried at cost or fair value less, where applicable, any accumulated depreciation and impairment losses.

Plant and Equipment

Plant and equipment are measured on the cost basis less depreciation and impairment losses.

The carrying amount of plant and equipment is reviewed annually by directors to ensure it is not in excess of the recoverable amount from these assets. The recoverable amount is assessed on the basis of the expected net cash flows that will be received from the assets' employment and subsequent disposal. The expected net cash flows have been discounted to their present values in determining recoverable amounts.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the company and the cost of the item can be measured reliably. All other repairs and maintenance are charged to the income statement during the financial period in which they are incurred.

Depreciation

The depreciable amount of all fixed assets are depreciated over the useful lives of the assets to the Committee commencing from the time the asset is held ready for use.

The asset's residual values and useful lives are reviewed and adjusted, if appropriate, at each balance date.

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains and losses are included in the income statement.

b. Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts. Bank overdrafts are shown within borrowings in current liabilities on the balance sheet.

Note 1. Statement of Significant Accounting Policies (continued)

c. Revenue

Grants are recognised at fair value where there is reasonable assurance that the grant will be received and all grant conditions will be met. Grants relating to expense items are recognised as income over the periods necessary to match the grant to the costs they are compensating.

Grants received for specific programs are recognised as income only to the extent of work completed on those projects when the terms of the grants stipulate that any unexpended funds are to be returned to the sponsor if the program is not completed. In those circumstances the funds attributable to work still to be completed are carried forward as grants income deferred.

Revenue is measured at the fair value of the consideration received or receivable.

Revenue from the sale of goods is recognised at the point of delivery as this corresponds to the transfer of significant risks and rewards of ownership of the goods and the cessation of all involvement in those goods.

Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets

Revenue from the rendering of a service is recognised upon the delivery of the service to the customers

All revenue is stated net of the amount of goods and services tax (GST).

d. Income Tax

By virtue of its aims as set out in the constitution, the Association qualifies as an organisation specifically exempt from income tax under Section 50-45 of the *Income Tax Assessment Act* 1997.

e. Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of an item of expense. Receivables and payables in the Balance Sheet are shown inclusive of GST.

f. Employment Entitlements

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to balance date. Employee benefits that are expected to be settled within one year have been measured at the amount expected to be paid when the liability is settled. Contributions are made by the association to employee superannuation fund and are charged as expenses when incurred.

g. Provisions

Provisions are recognised when the Association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured.

h. Related Party Transactions

The Committee Members act in an honorary capacity and are not paid for their services as Committee Members

There were no transactions with related parties during the 2025 year.

Opinion
